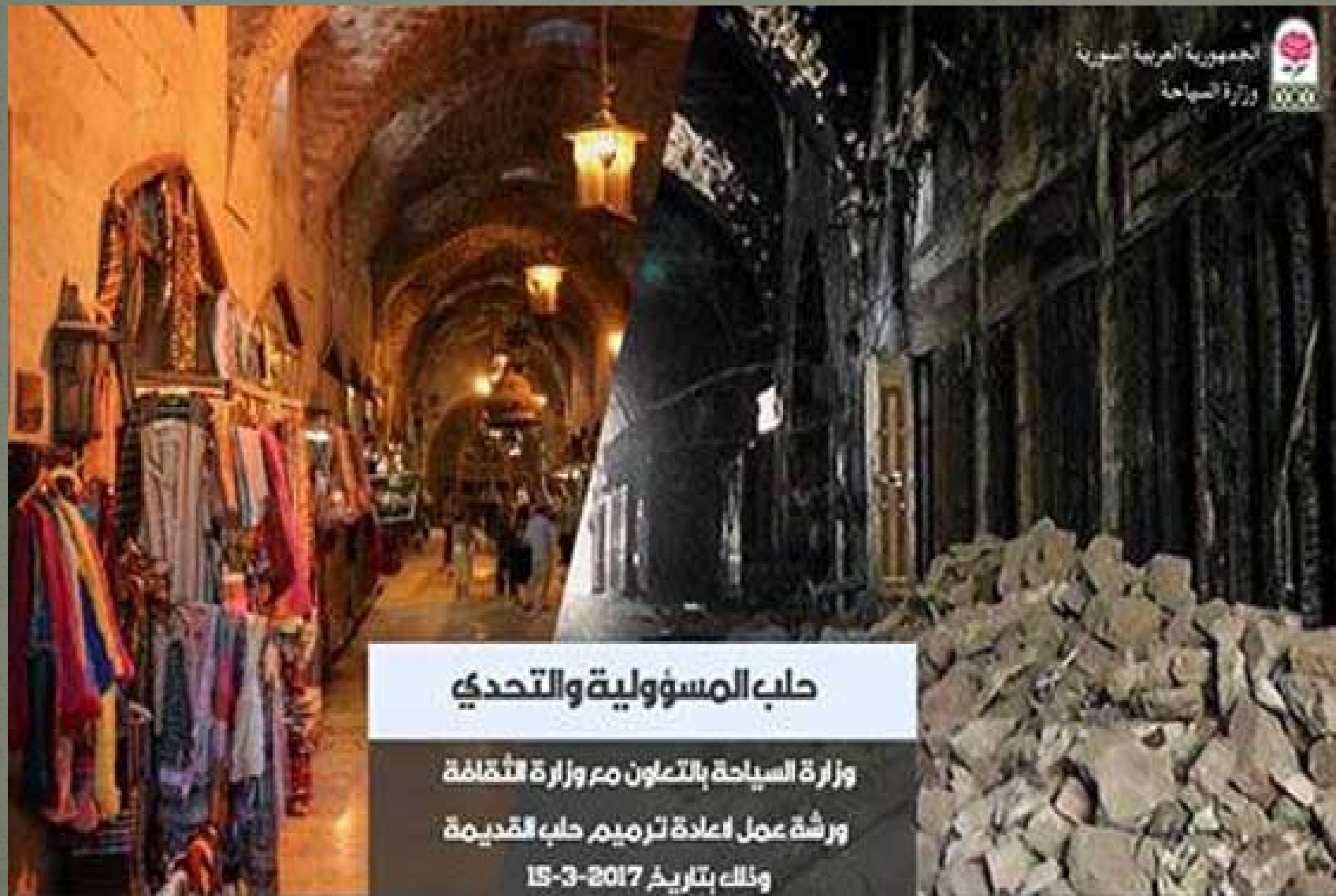

Third: New Investment Structure

- The following are the main axes of the new legislation expected to be issued early in 2020:

Ensuring equal opportunities for all investors, non-expropriation, non-confiscation, freedom of investment and preventing monopoly.

Reducing income taxes from 3-7 years according to investment map, development zones and priority sectors.



Fourth: The National Development Program for Postwar Syria

The program is implemented through a working mechanism issued under a separate document prepared by the Planning and International Cooperation Commission, which included:

- Need and justification.
- Program objectives and objectives.
- Stages of the program.
- Axes and components of the program.
- Program outputs.
- Program structure and management.
- Workflow for program development.
- Implementation requirements.
