This form is a binding agreement made between the exhibitor and the event organizer Pulse Media for Organizing Exhibitions. By signing this form you confirm your participation in the International Food and Technology Exhibition INFTEXPO - Amman 2020.



1. The preamble to the contract shall be considered an integral part and shall be read as a single unit.
2. This contract shall be binding upon the Parties at the time of its signature. The Second Party shall not be entitled to withdraw or cancel their participation, after signing it under any circumstances. In the event of its withdrawal, the contract shall be deemed to be valid and the Second Party shall be obliged to bear the remaining amount of the contract.
3. The second party undertakes to pay 50% of the value of the contract at the time of signature and the remaining 50% 20 days before the opening of the exhibition.
4. The second party may not sell any part of their booked rental area to any third party of the exhibitors unless the written consent of the first party is obtained. Otherwise, the first party has the right to terminate the contract, re-sell the space mentioned in the contract.
5. The First Party undertakes to hand over the booked area to the Second Party two days prior to the opening of the Exhibition.
6. The First Party shall not be liable for any loss suffered by the Second Party as a result of the intrusion or theft of the goods offered during, before or after the offer period.
7. The cost of all services not provided for in the contract shall be paid by the Second Party.
8. The Second Party is responsible for transporting and delivering the materials presented to and from the specified platform.
9. The Second Party shall declare its participation in the Exhibition of its own accord and on its own initiative. This contract shall not constitute an oral or written promise by the First Party at the level or success of the Exhibition.
10. The Second Party undertakes to comply with the items presented and approved by the First Party, and in failing to comply with this, it undertakes and commits to remove the Second Party from the Exhibition immediately if the First Party so requests.
11. This contract shall commence from the date of its signature and end at the end of the exhibition.
12. If a dispute arises as to, or due to, or as a result of this contract, the dispute shall be referred to the Jordanian Arbitration in accordance with the Jordanian Arbitration Law.
13. This contract consists of fourteen items and two original copies, each one holding one original copy.
14. Pulse Media for Organizing Exhibitions and Conferences (First Party) has the right to cancel any contract with any participant in the exhibition without reference to it, if necessary.
