



BB Energy responsibly trades and moves energy to where it is needed most, enabling economic and social development.

BB Energy has a legacy spanning more than six decades. Today, the Group provides expertise across energy trading, operations, logistics, storage, and retail. Its diversified portfolio cuts across many segments of the energy industryfrom trading crude oil and petroleum products to natural gas and renewables.



BB Energy is among the world's leading independent energy trading companies, with twelve strategically positioned offices around the globe and over 50 years of trading experience. BBE has consolidated experience in trading, operations, chartering, logistics, storage, refining, and financing, trading in excess of 41 million metric tonnes (MT) of crude oil, petroleum products, and gas.

BB Energy's global and diversified business footprint, excellent customer relationships, logistical expertise, strong risk management and governance processes, and our robust business model built on three key pillars -Agility, Adaptability, and Reliability - have been critical to ensure our continued success. We have responded swiftly to the severe dislocations in energy markets to deliver sustainable and affordable energy to our customers.

Another significant challenge faced by the industry is access to financing and liquidity to support the increased level of volatility in global markets. BB Energy's long-term trusted and transparent relationship with our banking and financial partners has allowed us to continue growing our financing lines to US\$ 4.3 billion.

In line with BB Energy's core strategy, we have focused on expanding our footprint and investments in growth regions, such as Africa and Latin America. These are markets where we have a unique understanding of the risks and opportunities, and are familiar with the political, financial, and socio-economic landscape. We also achieved a substantial increase in our geographical footprint and trading flows across the Americas. In this period, our headcount in the Houston office has grown by 20%, cementing a robust foundation for our continued growth in the region.

BB Energy has continued to support the Energy Transition and the path to Net-Zero. We have embarked on a transformational journey towards cleaner and greener energy. In January 2020, the Group established a Renewable Energy Division dedicated to managing and investing in renewable energy and emission reduction projects. We now have more than 30 members in the Renewable team which continues to grow steadily through the hiring of highly skilled personnel with decades of experience in renewable projects.

Since our acquisition of Solarcentury Africa (SCA) in 2021, we have experienced a remarkable growth and secured over 450 MW of solar projects. This platform provides the Group with access to a pipeline of 4 GW of solar energy and battery storage projects across Africa. BB Energy is dedicated to do more to help reduce carbon emissions worldwide. To further strengthen our commitment to innovation and decarbonisation, we are investing in energy innovation across different sectors.

Amongst many other projects, BB Energy has invested in Rwanda's first natural gas developer, Gasmeth Energy Global, which is focused on the responsible extraction, processing, and distribution of methane gas from Rwanda's Lake Kivu, one of the African Great Lakes. The gas will replace conventional fuels such as Gasoline, diesel and coal across the transport and power generation sectors in the country. This will lower greenhouse gas emissions from the country by approximately seven million tonnes of CO₂ equivalent. In addition to these endeavours, we have continued to expand our Carbon Trading Desk, which combines our trading capabilities with the desire to meet key climate goals. Over the past 12 months, our trading desk has secured 11 million tonnes of carbon credits, achieving a positive mark to market on each concluded trade.

We also took steps to support the development of local communities in the markets, in which we operate. For example, BB Energy launched a flagship project in Rwanda to replace traditional fire stoves with 500,000 Improved Cookstoves, which aim to reduce CO₂ emissions by a target of eight million tonnes. These highly energy efficient cookstoves reduce the volume of carbon emissions per household, alleviate deforestation through decreased demand for firewood and improve the health of users by curbing the emission of toxic fumes. The manufacturing of these new devices has also created 200 local employment opportunities. So far, around 80,000 Improved Cookstoves have been produced and distributed.

The European Film Academy was finally founded in 1989 as the European Cinema Society by its first president Ingmar Bergman and 40 filmmakers – among them Greek legendary filmmaker Theo Angelopoulos and film composer Mikis Theodorakis – to advance and protect the interests of the European film industry in a rapidly globalizing world. Wim Wenders (1996-2020) and Agnieszka Holland followed in Bergman's footsteps as Presidents of the Academy.

The 36TH EUROPEAN FILM ACADEMY AWARDS will be held on December 9, 2023, in Berlin.

Greek reforms drawing higher value-added investment, credit upgrades

Drawn by its support for businesses, innovation and human resources, foreign investors continue to see opportunities for Greece as the country moves ahead with a sweeping reform and restructuring program that is gaining the approval of international credit analysts.

A recent global survey by consultancy EY underscores how Greece's investor-friendly policies are leading both to increased foreign investment and new, higher value-added projects, that have placed Greece among the top 20 European countries surveyed for the first time. At the same time, the market-oriented policies of the past few years – combined with fiscal reforms – are ensuring future growth and its investment grade status, says ratings agency Standard & Poor's.

"This year's fifth edition of the EY Attractiveness Survey Greece confirms that our country's performance is improving, and Greece is gradually finding its rightful place on the global investment map," says Georgios Papadimitriou, Country Managing Partner of EY Greece. "The number of investment projects, as well as the intention for further investments, is increasing, their qualitative composition is improving, while the level of investor optimism for enhancing the country's attractiveness over the next three years is among the highest in Europe."

In particular, the report notes that some two-thirds of businesses surveyed say the country's efforts to promote innovation and human resources are among the top reasons for investing in Greece. It adds that a growing share of foreign investments is being directed into knowledge-based activities, such as software and information technology services, that are helping to further transform the country's economy.

In a separate report, international credit ratings agency S&P cites the structural and budgetary reforms Greece has undertaken in the last decade – and which it sees continuing – as justification for returning Greece to investment grade status. The one notch upgrade, to BBB- from BB+, is the latest in a series of ratings upgrades for the country with further upgrades expected in the months ahead.

The S&P announcement also highlights Greece's strong growth dynamics forecasting real GDP growth of 2.5% this year and averaging 2.6% over the next three years. "Expanding investment flows, improving labor market outcomes (unemployment is expected to decline to 9.2% next year from the peak of 28.2% in third-quarter 2013), and supportive credit conditions following banking sector normalization will underpin growth in the coming years, which we project will average 2.6% over 2024-2026," the report says.






A Business Conference Disrupted by a Painful Reality

On 18-19 October 2023, the Jordan Chamber of Commerce co-organized, along with the Arab League and the Union of Arab Chambers, the 20th Conference of Arab Businessmen and Investors, and the 1st Economic Summit of the Arab Private Sector to be held in Amman, Jordan.

However, due to a dire humanitarian crisis in Gaza, exacerbated by Israel's bombardment of the Palestinian coastal region, it was decided by the President of Jordan Chamber, Khalil ElHaj Tawfiq and the Arab delegates to cancel the two events and to underline the importance of fostering solidarity for 'Palestinian brothers' among all Arab states. Consequently, a newly formed platform, devoted solely to that purpose, gathered feedback from all the participants and composed a declaration, denouncing and condemning the Israeli aggression. The statement addressed the Arab private sectors, urging them to ask from their respective governments to express outrage over the enormous loss of lives of innocent children, women, and men of Gaza and to demand total ceasefire so that the Palestinian people could "preserve their humanity and their right to self-determination and to live in dignity within their homeland."

It is worth mentioning that this Conference was attended by Presidents of Arab Federations and Secretaries-General of Arab-Foreign Joint Chambers, among whom were our Secretary General, Mr. Rashad Mabger, and various business delegates from the Arab world.

Bidding Farewell to Ambassador Sulaiman




